

webinar week Terms of Use

The Webinar Week Secretariat (hereinafter referred to as the "Secretariat") establishes the "webinar week Terms of Use" (hereinafter referred to as the "Terms") as follows when providing online events and related services operated by the Secretariat (hereinafter referred to as the "Service").

These Terms stipulate the conditions for using the Service and apply to all participants of the Service (hereinafter referred to as "Participants"). **Please be sure to read these Terms before using the Service.**

Article 1 (Application and Amendment of the Terms)

1. All Participants shall use the Service in accordance with these Terms.
2. The contents of these Terms may be revised or changed at any time due to administrative convenience or other reasons. If the contents of these Terms are changed, the Secretariat shall notify Participants by posting the changes on the official website, via email, or by other reasonable methods.

Article 2 (Formation of the User Agreement)

1. Participants shall agree to these Terms and complete the registration procedure for using the Service (hereinafter referred to as "Registration") by the method designated by the Secretariat.
2. Upon completion of Registration, a user agreement (hereinafter referred to as the "User Agreement") containing these Terms shall be formed between the Participant and the Secretariat, and the Participant shall acquire rights and assume obligations as a Participant based on these Terms.
3. When registering, Participants must register true and accurate information for all items, and must not register false, inaccurate, or misleading information.
4. The Secretariat may refuse Registration if the Participant falls under any of the following items, and the Participant shall not raise any objection to such refusal:
(1) If all or part of the information provided to the Secretariat contains false statements, errors, or omissions.
(2) If the Participant registers by impersonating another person, such as by using another person's email address.
(3) If a person deemed identical to the Participant has already completed Registration, or has previously been refused, canceled, or terminated from a User Agreement.
(4) If it is found that the Participant or related parties of the Participant (hereinafter collectively referred to as "Members") fall under the category of organized crime groups (Boryokudan, etc.), are controlled by such

groups, or have relationships with such groups. (5) In any other case where the Secretariat determines that the Participant is unsuitable.

Article 3 (Notices and Communications)

1. Notices and communications (hereinafter referred to as "Notices") from the Secretariat to the Participant shall be made via email, posting on the website, or any other method deemed appropriate by the Secretariat.
2. When the Secretariat sends Notices via email, the Notice shall be deemed to have reached the Participant at the time the Secretariat transmits the email to the Participant. The Secretariat shall not be liable for any disadvantages incurred by the Participant due to the non-delivery of the email containing the Notices.
3. When the Secretariat sends Notices by posting them on the website, the Notice shall be deemed to have reached the Participant at the time the Notice is posted on the website.

Article 4 (Change of Registration Information)

1. If any change occurs in the email address, telephone number, corporate name, or any other information entered during Registration or separately notified to the Secretariat (hereinafter referred to as "Registration Information"), the Participant shall promptly notify the Secretariat of such change.
2. The Secretariat shall not be liable for any disadvantages or damages incurred by the Participant due to the Participant's failure to notify the Secretariat of the change pursuant to the preceding paragraph.

Article 5 (Third-Party Software, etc.)

1. The use of the Service may require the use of third-party software and services designated by the Secretariat. Participants must agree to and comply with the terms of use, etc., of such third-party software and services. **Please be sure to read the terms of use for such third-party software and services when using them.**
2. If a Participant violates the terms of use, etc., related to third-party software or services, the Secretariat may restrict or suspend the Participant's use of such third-party software or services, or terminate the User Agreement.

Article 6 (Management of ID and Password)

1. Participants shall strictly manage their own Business ID and password under their own responsibility, and the Secretariat shall not be liable for any leakage to third parties or unauthorized use by third parties. However, this shall not apply if the grounds are attributable to the Secretariat.
2. Participants shall not allow third parties to use, transfer, or lend their Business ID and password.
3. If the Service is used with a Participant's Business ID and password, the Secretariat shall deem such use to be by the Participant who set up that Business ID and password, and the effects thereof shall accrue to that Participant.
4. If the Participant's Business ID and password are leaked to a third party or if there is suspicion of unauthorized use, the Participant shall immediately report the matter to the Secretariat and follow the Secretariat's instructions. The Secretariat shall not be liable for any damages incurred or magnified by the Participant due to delay in such reporting.

Article 7 (Deletion of Registration)

1. If a Participant wishes to delete their Registration, they shall follow the deletion procedure according to the method prescribed by the Secretariat.
2. If Registration is deleted pursuant to the preceding paragraph, the User Agreement shall also be terminated, and the Participant shall lose their status as a Participant and will thereafter be unable to use the Service.
3. After the deletion of Registration, the lost status as a Participant and the Registration Information cannot be restored.

Article 8 (Usage Environment)

1. Participants shall prepare the necessary terminal, electronic equipment, communication equipment, software, and internet connection environment for using the Service at their own responsibility and expense. The Secretariat shall not be responsible for any defects in the use of the Service caused by the connection environment prepared by the Participant.
2. Communication fees and other costs incurred when using the Service shall be borne by the Participant.
3. If the Service is used via a proxy server, VPN server, or similar means, the Service may not be utilized normally due to errors, etc., associated with such servers.

Article 9 (Participant Responsibility)

1. If a dispute arises between the Participant and other Participants or third parties regarding the use of the Service, the Participant shall resolve such dispute at their own responsibility and expense.
2. If the Participant causes damage to other Participants or third parties regarding the use of the Service, the Participant shall compensate for such damage at their own responsibility and expense.
3. If the Participant causes damage to the Secretariat in connection with the use of the Service, the Participant shall compensate for such damage (including attorney fees) at their own responsibility and expense.

Article 10 (Acquisition, Use, and Provision of Personal Information)

1. The Secretariat shall acquire the personal information of the Participant (as defined by the Personal Information Protection Law; the same shall apply hereinafter in this Article).
2. The Secretariat shall handle the acquired personal information of the Participant in accordance with these Terms and the Privacy Policy established by the Secretariat.
3. The Secretariat may use the acquired personal information of the Participant for the following purposes, and the Participant agrees to such use: (1) For responding to inquiries related to the Service, and for the provision and operation of the Service. (2) For business matching with parties related to the Service. (3) For analysis and examination aimed at improving, enhancing functions, or otherwise changing the Service. (4) For distributing email newsletters and various other notices regarding the Service. (5) For contacting the Participant for the purposes of surveys, questionnaires regarding the usage status of the Service, and update reports, etc.. (6) For the creation of statistical data, analysis, and other marketing purposes. (7) For announcements, advertising, and promotion of the Service. (8) For distributing email newsletters and various other notices regarding third-party products, services, campaigns, and events or seminars organized by third parties.
4. For the purposes of use listed in items (2) and (7) of the preceding paragraph, the Secretariat may provide the Participant's personal information and other necessary information to third parties, and the Participant agrees to this in advance.

Article 11 (Prohibited Acts)

1. The Secretariat prohibits the following acts by Participants when using the Service: (1) Acts that infringe upon the copyrights, trademark rights, design rights, patent rights, utility model rights, or other intellectual property rights of the Secretariat, other Participants, or other third parties. (2) Acts that infringe upon the property rights, portrait rights, publicity rights, personal rights, reputation rights, privacy rights, or other rights of the Secretariat, other Participants, or other third parties. (3) Acts that violate public order and morals or laws and regulations. (4) Criminal acts, acts linked to criminal acts, or acts that encourage criminal acts. (5) Acts of registering or posting false information. (6) Acts that interfere with the Secretariat's operations, such as imposing excessive load on servers. (7) Acts of defamation, threat, harassment, discrimination, or acts that encourage these, or acts that cause disadvantages to the Secretariat, other Participants, or other third parties. (8) Acts of collecting or disclosing the personal information or privacy information of the Secretariat, other Participants, or other third parties without their consent. (9) Participating in the Service for the purpose of soliciting pyramid schemes or multi-level marketing (MLM). (10) Acts prohibited in the preceding items and these Terms, or any other act deemed inappropriate by the Secretariat.
2. The determination of whether an act falls under the prohibited acts of the preceding paragraph shall be made at the discretion of the Secretariat, and the Secretariat shall not bear any obligation to explain such determination.
3. If the Secretariat determines that a Participant's conduct falls under the prohibited acts specified in Paragraph 1, the Secretariat may, without prior notice to the Participant, restrict or suspend the use of the Service, delete the Registration, terminate the User Agreement, or take any other measures deemed necessary by the Secretariat, and the Secretariat shall not be liable for any damages incurred by the Participant as a result thereof.

Article 12 (Interruption/Cessation of Service Provision, etc.)

In the event that any of the following items applies, the Secretariat may interrupt or cease the provision of the Service and take necessary measures without notifying the Participant, and the Secretariat shall not be liable for any damages incurred by the Participant as a result thereof: (1) When performing maintenance, inspection, or security assurance for the system used for the Service. (2) When the provision of the Service becomes difficult due to force majeure, such as fire, power outage, accident, natural disaster, outbreak of infectious diseases, or interference by a third party. (3) When a system failure or network failure occurs. (4) When unauthorized use by other

Participants or third parties occurs. (5) In any other case where the Secretariat deems it necessary.

Article 13 (Modification, Addition, or Abolition of the Service)

1. The Secretariat may modify, add to, or abolish all or part of the Service, and the Secretariat shall bear no responsibility to the Participant regarding these actions.
2. When the Secretariat modifies, adds to, or abolishes all or part of the Service pursuant to the preceding paragraph, the Secretariat shall notify the Participant of such intention with a reasonable period of notice. However, this shall not apply in cases of emergency or unavoidable circumstances.

Article 14 (Disclaimer)

1. The Secretariat makes no guarantee whatsoever that the Service is suitable for the specific purposes of the Participant or possesses the specific quality or value expected by the Participant.
2. The Secretariat makes no guarantee whatsoever regarding the completeness, accuracy, certainty, reliability, usefulness, etc., of the Service, or the actual existence, identity, reliability, etc., of Participants.
3. Except as separately stipulated in these Terms, the Secretariat shall not be responsible for any disadvantages or damages incurred by the Participant due to the use of the Service, or any disadvantages or damages incurred due to the inability of the Participant to use the Service.
4. If the User Agreement between the Secretariat and the Participant constitutes a consumer contract under the Consumer Contract Act, provisions in these Terms that completely exempt the Secretariat from liability for damages shall not apply. In such a case, if the damages incurred by the Participant are based on the Secretariat's breach of contract or tortious act, the Secretariat shall be liable for damages limited to the scope of ordinary damages directly and actually incurred by the Participant (excluding damages relating to incidental damages, indirect damages, special damages, future damages, and lost profits), except in cases where the Secretariat acted with willful misconduct or gross negligence.

Article 15 (Content)

1. Intellectual property rights, such as copyrights, neighboring rights, trademark rights, and design rights, pertaining to all information provided through the Service, including video, audio, programs, text, images, illustrations, designs, trademarks, and logo marks (hereinafter referred to as "Content"), belong to the Secretariat or to the third parties who have licensed the use of such information to the Secretariat.
2. Participants shall not engage in any act that infringes upon the rights of the Secretariat or third parties regarding the Content.

Article 16 (Prohibition of Assignment)

The Secretariat prohibits Participants from assigning, selling, lending, succeeding, licensing, or otherwise disposing of their status as a Participant and the rights and obligations based on that status under the User Agreement to any third party.

Article 17 (Governing Law and Agreed Jurisdiction)

1. These Terms and the User Agreement shall be interpreted in accordance with the laws of Japan.
2. All disputes arising concerning the use of the Service, these Terms, or the User Agreement shall be submitted to the **Osaka District Court or the Osaka Summary Court as the court of exclusive agreed jurisdiction for the first instance.**
